### OVERVIEW

The client acknowledges having read and expressly accept the terms and conditions once a reservation is placed. In this sense, the Client accepts without reservation all the provisions set forth in these Terms say, to the exclusion of all others.

### SERVICE

The service is provided by staff from 12:00 to 22:00 every day and cannot exceed 11 p.m. unless specifically approved.

### IMPRINT OF THE RESERVATION REQUEST

Reservation requests must be made in writing by the Buyer. The booking request must imperatively include the following :

- Complete identity of the buyer (name, registered office, SIRET, VAT) Menus Groups that would like to book, the number of participants, the day and time of the passage, the payment method. These elements will be included, with prices for the services in the booking confirmation sent by e mail.

### QUOTATION – REQUEST

Reservations are final upon receipt :

- Written confirmation of the customer.
- The payment of the deposit up to 40% of the estimated tax estimates.

A failure to do so the company reserves the right to cancel the option without further notice

### GUARANTEE COVERED

The composition of the menu must be communicated to the restaurant at least D- 7 before the date of reservation. Any order changes must involve a minimum of 48 hours before the date of reservation. The final number of guests must be communicated to the Restaurant within the same period and will be retained as a basic minimum billing, even if on the day of the service, the number of guests is lower. In contrast, if the number of guests is higher, invoicing will be based on the actual number produced and served.

## SPECIFIC RATES AND CONDITIONS

Quotes are valid for 3 months from the date of dispatch to the customer. The amounts mentioned are the rates for the current year. All prices are inclusive of tax on a basis of 20 people minimum.

The current VAT rate will be applied, namely: 10% for food and beverage services "soft" and 20% for all alcoholic beverages, entertainment, and service and equipment rental. Any VAT increase occurred between order and the date of your arrival will be automatically passed without notice on the final bill.

## TERMS OF PAYMENT AND ARREARS

Unless otherwise agreed, payments shall be staggered as follows :

- 40 % deposit with order,
- Balance receipt of invoice.

No discount will be guaranteed. All total or partial late payment will result in the application of a penalty corresponding delay to the legal interest rate plus 10 points. In addition, a lump sum compensation for recovery costs in the amount of € 80 will be required for non-compliance with payment conditions.

## ORDER CANCELLATION

Any cancellation occurring:

- Before 3 months will not be charged
- Between three months and one month will be charged 20 % of the amount all taxes included of the invoice;
- Less than 7 days before the date of delivery will be charged 80 % of the amount of the invoice VAT.

## DEGRADATIONS

Any damage (dishes, material ...) caused during delivery, the Customer and its participants will be charged according to our schedule.

## BAIL

In some cases, a deposit may be required to the customer (student parties ...).

If no damage is found, it will be returned in full. If, however, degradation has occurred (breakage, destruction of material ...), all or part of the deposit will be retained in proportion to the costs involved.
